INDISPENSABLE FOR PKU/HPA

- **XPhen minis** replace that amount of protein in the diet, which may not be taken in from natural foods.

Healthy people meet their requirements of amino acids through food rich in protein, people with PKU/HPA through their protein supplement, e.g. **XPhen minis**.

DOSAGE

- The daily total amount of amino acid mixture depends on age, body weight and individual medical condition and/or protein tolerance. The dosage should be re-examined and adjusted according to the results of regular medical monitoring.
- The daily dosage of protein substitute should at best be divided into 3 – 5 single portions.
- **XPhen minis** can also easily be combined with other **XPhen**-products from our large product portfolio for PKU/HPA.
- The PKU-diet must be supplemented with energy, natural protein and other nutrients in prescribed quantities.

INTAKE

- **XPhen minis** should be swallowed unchewed as whole tablets. They should always be taken with a sufficient quantity of liquid. **XPhen minis** are not meant to dissolve in the mouth. Do not dissolve the tablets in water or other liquids. We recommend to take the tablets in an upright position. Once sachet is opened, tablets should be taken within the next 6 hours.

Note: *XPhen minis* are coated with a flavour-neutral layer. This outer coating makes the tablets easy to swallow. The protective coating is extremely thin and water-soluble. If this coating were to dissolve, the tablets would taste like a typical amino acid mixture.

- **XPhen minis** should preferably be taken along with calculated amounts of Phe-containing food according to individual protein tolerance.

IMPORTANT NOTICE Must only be used under medical supervision. Not for use as a sole source of nutrition. For enteral use only. Only for people from 7 years of age with proven Phenylketonuria (PKU) or Hyperphenylalaninemia (HPA).

Tip Especially for women, before and during pregnancy and during breastfeeding, **XPhen for2 minis** are available: A protein supplement in tablet form, free of Phenylalanine, enriched with vitamins, minerals and trace elements – in amounts, according to the special needs in this special time of life.
